Bids received in excess of the ABC shall be automatically rejected at bid opening.
  - The Municipality of Cuyapo, Nueva Ecija now invites bids for INSTALLATION OF SOLAR STREET LIGHTS, SAN JOSE-CURVA ROAD. Completion of the above project must be within seventy-five (75) calendar days. Bidders should have completed within 3 years from the date of submission and receipt of bids a contract similar to the Project. The description of an eligible bidder is contained in the Bidding documents, particularly, in Section II, Instructions to Bidders.
  - Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from the Municipality of Cuyapo, Nueva Ecija and inspect the Bidding Documents at the address below from Monday to Friday at 8:00-12:00 NN and 1:00-5:00 PM.
