The Municipality of Cuyapo, Nueva Ecija now invites bids for CONSTRUCTION OF FARM TO MARKET ROAD, BARANGAY SALAGUSOG. Completion of the above project must be within 80 calendar days. Bidders should have completed within 3 years from the date of submission and receipt of bids a contract similar to the Project. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p> <p>4.
