BAC RESOLUTION RECOMMENDING ALTERNATIVE METHOD OF PROCUREMENT THROUGH NEGOTIATED PROCUREMENT AND RECOMMENDING APPROVAL TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE AWARD OF CONTRACT TO “CHRISTIAN CONSTRUCTION SUPPLY”

(for ABCs with >Php 50,000 and ≤ Php 200,000)

WHEREAS, the Municipality of Cuyapo, seeks to attain economy and efficiency in all aspects of its procurement operations by resorting to the above-mentioned Alternative Method of Procurement consistent with rule XVI of the implementing Rules and Regulations of Republic Act No. 9184.

WHEREAS, the LGU Cuyapo – BAC was tasked to evaluate the Purchase Request for;
“Installation of Cabinet at RHU 1 Building”
(PhilGEPS Ref. No. 11035711);


WHEREAS, said materials are included and conformed to the approved budget of the end-user’s Project Procurement Management Plan (PPMP), and Annual Procurement Plan (APP) for CY 2024;

WHEREAS, the following are the reasons for the purchase of said goods: **(Php 71,591.00 - ABC)**


- That the amount involved is above Php 50,000.00 but below Php 200,000.00 which is an small amount to justify the conduct of public bidding and within the thresholds prescribed in Annex “H” of the 2016 Revised IRR of RA 9184.
- The goods are not available/offered/out of stock at the DBM Procurement Service.
- That procurement of these goods do not fall under the prohibition on “Splitting of Government Contracts”.
- LGU Cuyapo has ensure that the objectives and purpose of the contract do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure.
- That the BAC shall validate the technical, legal, and financial capability of the supplier/s by requiring the submission of relevant documents or through other means prior to recommendation of award to the HOPE.

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To recommend Alternative Method of Procurement through Negotiated Procurement as provided in Sec. 53.9 and 54 of the Consolidated Guidelines for the Alternative Methods of Procurement of the Annex “H” of the Revised IRR of RA 9184 for the above-cited goods/services; and
- To recommend to the Municipal Mayor of the Municipality of Cuyapo, Nueva Ecija/ Head of Procuring Entity (HOPE) the approval of this Resolution and the award of the Contract/Purchase Order to the Supplier/Contractor.
