  - The Municipality of Cuyapo, Nueva Ecija now invites bids for CONCRETING OF ROADS/FMR (BARANGAY MALINENG TO SITIO MANCAEG). Completion of the above project must be within 200 calendar days. Bidders should have completed within 3 years from the date of submission and receipt of bids a contract similar to the Project. - Bidding is restricted to Filipino citizens/sole proprietorship's, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
